## Foster Parent Emergency Placement Registration

April 2015

Dear SaintA Parent,

We understand that you may need care for your child as soon as possible because you are accepting an Emergency Placement of a Foster Child. I am writing to inform that the Milwaukee YMCA wants to make this as easy as possible for you. We offer Early Childhood Education, Before and After School Programs, School's Out Days, and Summer Day Camp at several Milwaukee area locations. Please refer to our website, [www.ymcamke.org/childcare](http://www.ymcamke.org/childcare) for more information on the types of camps and programs we offer as well as detailed pricing information. Pricing information for ECE is obtainable from the Early Childhood Director listed below. We want to assure you that your registration will be processed as quickly as possible if we have availability.

**Wisconsin Shares:** If your authorization is not approved by the day you need care for your child, we will accept your child without full payment for up to two (2) weeks from the day of placement. Please work diligently to get the authorization approved. It is important to understand that if you do receive Wisconsin Shares for your child's fees, it may not fully cover the entire cost of the program. In this event, you may be eligible for a Y scholarship for 10-50% off the remaining balance or co-pay. Please inquire with the specific Y Director for more information. (see below)

**Y-Membership:** Your entire family may also join the Y at a small cost to you. All children enrolled on a full-time basis in the Milwaukee Y's Early Childhood Education and Before and After School Programs qualify for a free Youth membership to our Y that can be upgraded to a Family Membership for only \$35 a month.

**To register your foster child for any of our programs, you will need to:**

- 1). Complete the registration form which is included for Day Camp and Before and After School Programs or contact Christine Larson to obtain a registration form for ECE registration. Please include any immunization records if available.
- 2). Apply for Wisconsin Shares
- 3). Fax or mail the completed forms to the YMCA of Metropolitan Milwaukee Program Services Office, 161 W Wisconsin Avenue, Ste. 4000, Milwaukee, WI 53203; fax 414-224-3323 or scan and e-mail to the appropriate department contact below.

Upon receipt of your completed registration form, a member of our staff will contact you to confirm your child's start date and fee.
